<p>NI Oxygen Audit (GAIN, 2011) results confirmed a lack of clarity around referral processes with no standardised assessment and review of patients. Home oxygen assessment and review services (HOSAR) have now been established in all Trusts to provide structure and governance around oxygen assessment.</p>
