## Q1. Does your organisation commission any services for people with DMD?

A1. There are no dedicated services within Community Children's Services (CCS) for children and young people with DMD. Children are supported across a number of services, depending on individual need and may receive the services of Community Paediatricians, Nurses and Allied Health Professionals (AHPS), AHPs see and support these children and young people through their schools based service. Community Children's Nursing Team (CCN) support children and young people with DMD as required, predominantly through supply of equipment, e.g. profiling beds, hoists, overbed table, and where airway management is required.

Medical care is coordinated mostly by the Regional Tertiary Neuromuscular Clinic within Belfast Trust.

With regard to Adults with DMD, the Trust do not have a specific neurology clinic for patients.

## Q2. If no, does your organisation expect to commission services for DMD in the future?

- A2. No, the Regional Neuromuscular service for Paediatrics and Adults is based in the Belfast Health and Social Care Trust.
- Q3. If yes, what services for people with DMD does your organisation commission?
- A3. As the Trust does not commission any services for people with DMD, this question does not apply.
- Q4. How many people with DMD does your organisation serve?
- A4. There are fewer than 10 young people on the AHP, Community Paediatrician and CCN caseloads in the Trust, with a confirmed diagnosis of DMD.

With regard to Adults with DMD, the Trust does not hold the data on the number of patients with DMD who reside in the Trust area.

Q5. Does your organisation have any DMD-specific (or muscle-wasting disease-specific) policies or guidance?

- A5. There is the Regional Pathway Guidance for a Child with Duchenne Muscular Dystrophy (DMD/MD) or Suspected DMD/Muscular Dystrophy; Northern Ireland, for Physiotherapists. Paediatric Occupational Therapy Pathways of Care are currently under review by the regional managers' subgroup.
  - With regard to Adults with DMD, the Trust does not have any DMD specific (or muscle-wasting disease specific) policies or guidance.
- Q6. Do any of your organisation's strategies, objectives, plans, performance indicators, audits, inspections, or similar, cite DMD (or any muscle-wasting disease) or use either as a metric?
- A6. No, not within Children's Community Paediatric Services, Community Children's Nursing, Paediatric Physiotherapy, Occupational Therapy, Speech and Language Therapy or Adult Services.

- A7. The Trust Community Paediatricians are aware of this work.
